If accepted by the Committee on Admission and with my payment of the deposit, please enter my child as a student in Fort Lauderdale Preparatory School (FLPS) for the full school year 2023-2024.

Admission is subject to general statements, rules, regulations, conditions, traditions, and financial terms contained in the Student/Parent Handbook, the Calendar and the Tuition/Fee Schedule, which are acknowledged to be a part hereof and the following additional conditions and terms.

When an applicant is accepted, a \$200 deposit is required. The deposit is non-refundable and constitutes good faith consideration to bind this contract.

Upon return of the Enrollment Application and Contract and a non-refundable \$200 deposit per child, we will reserve a place for your child for the 2023-2024 school year.

- 1. **ALL STUDENTS ARE ENROLLED FOR THE ENTIRE YEAR UNLESS IT IS EXPRESSLY AGREED IN WRITING TO THE CONTRARY.** Should the application be withdrawn prior to entry, the application fee and the deposit will be retained by the school as consideration for accepting the student. After July 1<sup>st</sup>, I agree that no reduction of my obligation to pay the full year's tuition and fees can be otherwise made for absence, voluntary or involuntary withdrawal or expulsion. All accounts must be paid in full before credits/records can be transferred to other schools and colleges. Students will not be allowed to continue to attend classes unless tuition is paid by stated deadlines unless other written arrangements are made. The school has the right to terminate the attendance of any student for reasons set forth in the Student/Parent Handbook, including the failure of parents to pay part or all of their financial obligations for the student's attendance. All monies due must be paid in full upon student's separation from school.
- 2. FLPS is not responsible for damages to or loss of any and all personal belongings.
- 3. By enrolling in Fort Lauderdale Prep School (FLPS) you grant permission to FLPS to take and use your photo in FLPS marketing and promotional pieces for an indefinite period of time without compensation or fee. Marketing and promotional pieces include, but are not limited to, printed brochures, reports, postcards, TV commercials, flyers and materials, as well as online uses such as postings on the FLPS website, online newsletters and email blasts. FLPS shall own all rights, including copyrights in and to the photos.
  - I affirm that I have supplied Fort Lauderdale Prep School with all school records, testing and all information regarding my child's academic, behavioral and emotional history and any other relevant information. I understand that failing to do so may be cause for dismissal.
- 4. Candidates of FLPS must submit the appropriate report cards (grades 1-9) or unofficial transcripts (grades 10-12). I hereby authorize FLPS to contact schools and other sources to obtain information to support this application and I will not seek access to any confidential recommendation and evaluation materials before or after my child's admission. The undersigned releases every person and institution from any and all liability resulting from or pertaining to the furnishing of records, documents and other information provided to FLPS for that purpose.
- 5. A positive working relationship between FLPS and a student's parents/guardian is essential to the success of FLPS' educational goals. FLPS reserves the right not to extend the re-enrollment to a student if FLPS reasonably concludes that the actions of a parent(s)/guardian(s) make such a relationship impossible or otherwise seriously interfere with FLPS' accomplishment of its educational goals. Grade/classroom placement is determined by FLPS and does not constitute a part of this contract or its subsequent renewals. Such grade/classroom placement is governed by FLPS administered tests and the Student/Parent Handbook. I will review and agree to abide by the provisions of the Student/Parent

Handbook. Any conduct by a student which is in violation of the Student/Parent Handbook and which the administration considers detrimental to the student or to other students, may be deemed adequate cause for appropriate disciplinary action, including suspension or dismissal.

- 6. If my child needs medical or surgical services which requires my authorization or consent before the same can be supplied by the undersigned, I hereby authorize, appoint and empower FLPS to act as my agent to furnish on my behalf such oral or written authorization as may be required, and I release FLPS from any and all liability which might arise from giving such authorization; it being my desire that my child be furnished with such medical or surgical services as soon as reasonably possible after the need arises.
- 7. If my child enrolls, I understand that all students are expected to leave campus immediately after classes end or at the conclusion of their participation in school-sponsored or school-supervised activities. I guarantee to provide appropriate supervision of any time on campus before school supervision or classes begin.

There is a fee for Aftercare (inquire at the school office for hours and charges) and there is also an additional charge if your child is picked up late after the school office closes.

- 8. I understand that the laws of the State of Florida and the regulations of FLPS require students in all grades (Pre-Kindergarten-Grade 12) to have on file before attending the first day of classes specific records (HRS 680 Part A/B/C (immunization), HRS 3040 (physical/health), birth certificate/passport and Social Security Card). In addition, students in Grades 7-12 participating in interscholastic athletic competition are required to submit an original birth certificate (or an official passport), parental approval, and a physical examination to establish eligibility.
- 9. A campus visit/interview for the candidate and family is required.
- 10. If this Contract must be placed in the hands of an attorney for enforcement and/or collection, the undersigned agrees to pay all costs of enforcement and/or collection which shall include, but not be limited to, reasonable attorney's fees and costs.
- My signature affirms that the information given in this application is true and correct and that my child(ren) have/has my permission to participate in field trips with Fort Lauderdale Preparatory School from August through June. This form will preclude the need to sign individual field trip Permission Forms for the 2023-2024 academic school year. This signed permission slip is required to participate in all field trips. If visiting the Broward county court house, students may be asked to sit in ongoing court proceedings and observe an actual trial. In the event of a serious illness, accident, or injury that would require medical attention, your child will be seen at the nearest Emergency Room. Your signature below indicates permission to consult the E-R Physician while you are being contacted.
