2025-26 FINANCIAL AID APPLICATION

Ft. Lauderdale Preparatory School (FLPS) recognizes the unique financial circumstances of each family. Depending on the amount of monies available in the Financial Aid annual budget, we offer awards for students on a limited basis. These awards are offered after a careful evaluation of individual family finances.

Within the limits of available funds, FLPS seeks to provide tuition assistance to qualified students. The schools policy for determining financial need is based on the principle that both parents are responsible for the support and educational expenses of their children. We consider the assets of both parents, if living, before making the award. Both parents are assumed to be employed. If only one parent is employed and there are no children under the age of four years living at home, the committee will add in a reasonable expectation of salary for that parent. If the custodial parent has remarried, we will consider the assets of the step-parent, taking into consideration the obligations to his or her natural children.

Returning students are given preference, providing they meet all deadlines. **Financial Aid must be applied for each year and applicants must meet all guidelines set forth by the Financial Aid committee.**

PLEASE NOTE: ONCE AN AWARD IS OFFERED BY THE COMMITTEE, THEY CONTINUE TO REVIEW THAT STUDENT'S GRADES, OVERALL CITIZENSHIP, PARTICIPATION IN THE SCHOOL COMMUNITY, AS WELL AS DISCIPLINARY AND ATTENDANCE COMPLIANCE ON A QUARTERLY BASIS. IN ORDER TO CONTINUE TO RECEIVE FINANCIAL AWARDS, STUDENTS MUST MAINTAIN A MINIMUM OF A 'C+' (2.5) AVERAGE AND ADHERE TO THE HIGHEST STANDARD OF DISCIPLINE AND DECORUM AND ALL TUITION PAYMENTS THAT ARE THE OBLIGATION OF THE PARENT MUST BE CURRENT. LAPSES IN ANY OF THE ABOVE MENTIONED CATEGORIES MAY RESULT IN THE DISCONTINUATION OF THE AWARD. AWARDS ARE OFFERED ON AN ANNUAL BASIS BUT REVIEWED AND DISTRIBUTED EACH MARKING PERIOD.

In order to receive a FLPS scholarship award, applicants must submit applications, meeting all deadlines pertaining to any and all other applicable scholarships available, i.e.; AAA, FES, FES-UA, FTC and the Early Learning Coalition. Failure to do so will result in ineligibility for an FLPS award. Proof of application to said scholarship programs must accompany the FLPS Financial Aid application.

Financial Aid awards are primarily based on the financial needs of the family, per the information provided. The entire process is confidential. Each family must expect to contribute something towards their child's education.



FREQUENTLY ASKED QUESTIONS

I am not sure if our family will qualify for Financial Assistance. Is it worth applying?

If you are unsure whether or not you will qualify, contact the Director of Admissions for advice. Since many financial factors enter in to the determination of Financial Aid, it is usually best to apply.

I received an award last year. Do I need to apply again?

Yes. All students must apply for Aid each year. Awards are granted on a first come, first served basis. There is a finite amount available for awards each year.

Will my Child's Financial Aid award change from year to year?

Financial Aid is recalculated each year using current financial information. Other factors affecting yearly awards are the amount of funds available for disbursement and the number of requests. It is recommended to apply early for Financial Aid.

When will we be notified if we are to receive an award?

The earliest decisions regarding financial awards are towards the end of May. Returning students should re-enroll and submit their completed Financial Aid application at the earliest date possible. New students will be notified of their awards as they are reviewed.

Will applying for Financial Assistance affect my child's chances for admission?

No. Students are admitted for FLPS based upon their academic ability and willingness to learn, not their financial status. Admission decisions are made separate from Financial Aid decisions.

What if I have more than one child in the school?

Award of Scholarships for families are looked at as a total package. Multiple scholarships can be awarded to families. FLPS offers a family discount program that will be included in the total package.

What if I receive AAA, FES, FES-UA, FTC or Early Learning Coalition money from the State?

All state funds are considered as a direct payment from you as they are received. Those funds will be counted toward your tuition and will not influence whether or not you will receive a FLPS Scholarship award.
